CIRCULAR LETTER

TO : ALL NON-LIFE INSURANCE COMPANIES

**SUBJECT : INSURANCE COMMISSION – COMPULSORY INSURANCE
DATABASE SYSTEM (IC-CIDS)**

In preparation for the implementation of IC-CIDS for Compulsory Motor Vehicle Liability Insurance (CMVLI), a walk through on the said system will be held at our Office on July 6, 2007 at the time indicated in the attached schedule.

The IC-CIDS-CMVLI is designed to serve the following objectives:

1. To build a capacity in the Insurance Commission (IC) to monitor and authenticate CMVLI transactions;
2. To establish a system for the sharing of information between the IC and the Land Transportation Office (LTO) on authenticated CMVLI transactions and motor vehicle registrations;
3. To develop an information facility for the Filipino motorists in general on current CMVLI transactions, thereby facilitating their availing of CMVLI benefits, if and when they fall due;
4. To improve the collection of taxes on CMVLI; and
5. To deter or put a stop to any illegal practices with respect to the implementation of CMVLI.

All non-life insurance companies are therefore enjoined to designate one (1) authorized representative to attend the session on IC-CIDS.
