- 2. The *Insurance Commission* now invites bids for each or all of the above-enumerated lots on the Supply and Delivery of Vitamin Supplements for CY 2017. Delivery of the Goods is required as specified in the Schedule of Delivery. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government

Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from the Insurance Commission Bids and Awards Committee and inspect the Bidding Documents at the address given below during office hours, 9:00 AM to 5:00 PM, Monday to Friday, except holidays.

Bid opening shall be on <u>20 June 2017, 2:00 PM</u> at Function Room, Insurance Commission Building, 1071 U.N. Ave., Ermita, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
