1. Amendment of Section III. Bid Data Sheet under ITB Clause 29.2 is hereby amended as follows:

	 Bureau of Internal Revenue (BIR) Certificate of Registration or BIR Form 2303; Certification from the manufacturer that they are certified reseller or partner of the proposed equipment; and Brochures.
	NOTE: The latest income and business tax returns are those filed within the last six (6) months preceding the date of bid submission.
	Latest Annual ITR shall refer to the ITR for the year 2017 filed in 2018 . For new establishments, which have no annual ITR yet, it shall refer to the most recent quarter's ITR. Further, for areas where e-filing is yet to be implemented, a Certification to that effect from BIR main office is acceptable.
	Latest Business Tax Return refers to Value Added Tax (VAT) and/or Percentage Tax Returns, whichever is applicable covering the last quarter and month prior to the bid opening. Bidders filing both the VAT and Percentage Tax Returns must submit both returns.

	Latest Business Tax Return refers to Value Added Tax (VAT) and/or Percentage Tax Returns, whichever is applicable covering the last quarter and month prior to the bid opening. Bidders filing both the VAT and Percentage Tax Returns must submit both returns.
