**SUPPLY OF SECURITY SERVICES FOR THE INSURANCE COMMISSION

A THREE (3) YEAR SERVICE AGREEMENT
(Project Reference No. 2019 – 03 - 078)**

This Supplemental Bid Bulletin No. 1 dated 30 April 2019 is being issued to clarify, modify, or amend items in the Bidding Documents.

The following Items in the Bidding Documents for the ***Supply of Security Services for the Insurance Commission (Manila, Cebu and Davao District Offices) and its Premises under a Three (3) Year Service Agreement*** dated 22 April 2019 are hereby revised/amended:

1. Amendment of Invitation to Bid, item no. 1 is hereby amended as follows:

FROM :

The **Insurance Commission through its Bids and Awards Committee (BAC)** intends to apply the sum of **Eight Million Forty Thousand Four Hundred Pesos (Php8,040,400.00)**, inclusive of 12% VAT, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply of Security Services for the Insurance Commission (Manila, Cebu and Davao District Offices) and its Premises under a Three (3) year Service Agreement**. The contract to be bid has a duration of three (3) years. However, the mentioned ABC is for the first year only. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **Insurance Commission through its Special Account in the General Fund 151 and Multi-Year Obligational Authority (MYOA) No. MYOA-BMB-A-18-0000084** issued by the Department of Budget and Management (DBM) dated 12 November 2018 intends to apply the sum of **TWENTY FOUR MILLION ONE HUNDRED TWENTY THOUSAND PESOS (Php24,120,400.00)**, inclusive of 12% VAT, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply of Security Services for the Insurance Commission (Manila, Cebu and Davao District Offices) and its Premises under a Three (3) year Service Agreement**. The contract to be bid has a duration of three (3) years. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bid opening shall be on **07 MAY 2019, 200 P.M.** at **IC Function Room, Insurance Commission, 1071 United Nations Avenue, Ermita, Manila.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
