II. The following items are given **CLARIFICATION:**

A. SUBMISSION OF PHILGEPS CERTIFICATE

Pursuant to Section 25.2 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, submission of a valid <u>PLATINUM MEMBERSHIP</u> Certificate from the PhilGEPS, provided that Annex A of the said Certificate must be attached, shall suffice as compliance with Class "A" Eligibility Documents, per Item 12.1. (a)(i) Section II. Instructions to Bidders (ITB), and the non-submission of the FOLLOWING as part of the bidding documents shall not be a ground for "failed" rating during the bid opening:

- Registration certificate from the Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives;
- Mayor's/Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas;
- Tax Clearance from the Bureau of Internal Revenue; and,
- Audited Financial Statements

Only bids with valid <u>PLATINUM MEMBERSHIP</u> Certificate from the PhilGEPS shall be accepted as "passed". All bids not supported by platinum membership shall be given a "failed" rating during bid opening.

B. SUBMISSION OF ADDITIONAL DOCUMENTS FOR TECHNICAL COMPONENTS (ITEM 12.1., SECTION III. BID DATA SHEET)

 Submission of the actual product insert of the vitamin supplements shall likewise suffice as compliance to the submission of complete product description as required in Item 12.1., Section III. Bid Data Sheet. Actual product insert refers to the product description document which is placed inside the packaging (i.e. box or bottle) of the vitamin supplements.

C. TECHNICAL SPECIFICATIONS OF VITAMIN SUPPLEMENTS (SECTION VII. TECHNICAL SPECIFICATIONS)

 The goods offered by the bidder/s in their respective bids must comply with the technical specifications of the vitamin supplements as required in Section VII. Technical Specifications.

This Supplemental Bid Bulletin No. 1 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly. Items not specifically amended and/or modified including those only supplemented are considered retained and/or applicable.
