

## **PRUDENTIALIFE PLANS, INC. (PPI)**

### **NOTICE TO PLANHOLDERS**

Starting December 15, 2016, we shall be releasing checks representing the **third tranche distribution to educational planholders**, and the **second tranche distribution to life and pension planholders**. We are very pleased to inform you of the following:

- For educational planholders, this third tranche will bring the total amount distributed to over 120% of the amount initially determined as distributable to educational planholders;
- For pension planholders, this second tranche will bring the total amount distributed to over 110% of the amount initially determined as distributable to pension planholders; and
- For life planholders, this second tranche will bring the total amount distributed to over 90% of the amount initially determined as distributable to life planholders.

#### **PROCESS FOR CLAIMING:**

We shall be publishing the updated list of planholders with checks for pick up at the website of the Insurance Commission at [www.insurance.gov.ph](http://www.insurance.gov.ph) on or before December 7, 2016.

To claim the checks, all planholders must first make a prior call or email us to schedule the pick-up of the checks after December 7, 2016. Most of the amounts of checks are minimal so please assess whether it is cost-efficient to personally claim your checks, and advise us so we can arrange alternative ways of giving you your checks. If this is your first time to claim a check, you will be required to present two (2) valid IDs, policy contract, certificate of full payment of the concerned plan and Special Power of Attorney, when applicable.

Personal pick-up of checks may be done, as scheduled in the prior call or email, either at **Prudentialife Plans, Inc. (PPI) Office at 7F Galleria Corporate Center Condominium corner EDSA Ortigas Avenue, Quezon City** or at **SYMECS LAW - PPI Liquidator's Office at 3111 One Corporate Center J.Vargas cor. Meralco Ave., Ortigas Center, Pasig City**, from 8:30am to 5:30pm, Monday to Friday.


