The supplier shall be paid the contract amount in full upon delivery and acceptance by the IC, subject to deduction of applicable taxes.


IV. GENERAL CONDITIONS:

1. All quotations must be typewritten in the company's letterhead.
2. ***PhilGEPS Registration Certificate, Signed Omnibus Sworn Statement, Mayor's Permit, and Income/Business Tax Return*** shall be attached upon submission of the Quotation.
3. All bid prices shall be considered as fixed price, and therefore not subject to price escalation during contract implementation
4. All quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.
5. Late delivery shall be subject to penalty equivalent to 1/10 of 1% of the total cost of undelivered items.

AFFIDAVIT
