## NOTICE TO THE PUBLIC

Notice is hereby given that the Insurance Commission (IC), in its issued Directive that was posted in the IC-website on 10 December 2021, has already decided to officially set the deadline or cut-off date for accepting the claims filed against <u>PHILIPPINE PRUDENTIAL LIFE INSURANCE COMPANY, INC.</u> (PPLIC).

The aforementioned deadline should have already expired within ninety calendar days (90) from the issuance of the sad Directive. However, we find it necessary to exercise liberality on this matter for the greater interest of fairness. Therefore, the issuance of this **Final Notice to the Public**, which will further extend the filing of claims against the company for another ninety (90) calendar days from the date of the last publication of this Notice on <sup>29</sup> \_\_\_\_\_\_ JUNE **2022 or until** \_\_29 \_\_\_\_\_ SEPTEMBER \_\_\_\_\_ **2022** is necessary.

Parties having claims against the company who have not yet filed are hereby notified to file their claims under oath with the Liquidator, **Atty. Iris Sylvia Lucero Bonifacio**, not later than the final deadline set herein, together with all supporting documents detailing the character, basis and amount of each and every claim, either personally or by mail directly with the designated Liquidator's address at 5<sup>th</sup> Floor, AIC Burgundy Empire Tower, ADB Avenue, Corner Garnet and Sapphire Roads, Ortigas Center, Pasig City or the Insurance Commission, 1071 United Nations Avenue, Manila, for consideration in the company's liquidation pursuant to pertinent provisions of the Amended Insurance Code.

THIS SHALL SERVE AS FINAL NOTICE OF LIQUIDATION OF PPLIC. HENCE, CLAIMS FILED AFTER 29\_<u>SEPTEMBER</u> 2022 SHALL BE BARRED FOREVER AND SHALL NOT BE ALLOWED TO PARTICIPATE IN ANY MANNER WHATSOEVER IN ANY KIND OF DISPOSITION, PARTITION, DISTRIBUTION, OR SETTLEMENT IN THE LIQUIDATION PROCEEDINGS AGAINST THE ABOVE-MENTIONED INSURANCE COMPANY. HENCE ALL CLAIMANTS ARE REMINDED TO FILE THEIR CLAIMS ON TIME.
