## NOTICE OF LIQUIDATION

Notice is hereby given to all policyholders, claimants and creditors of **FILIPINO MERCHANTS INSURANCE CORPORATION (FILMER)** that the final liquidation proceedings of **FILMER** is on-going.

The Insurance Commission (IC) had previously caused the publication of a Notice to the Public requiring parties having claims against **FILMER** to file their claims under oath not later than May 31, 2007.


Parties who filed their claims with the Liquidator of the company based on said prior publication are hereby requested to submit within thirty (30) days from date of publication hereof on 20 OCTOBER 2022, or until 19 NOVEMBER, 2022, proof of filing made with the said Liquidator directly to the Conservatorship, Receivership and Liquidation Division (CRLD) of the IC with office address at Insurance Commission Building, 1071 United Nations Avenue, Ermita, Manila, with telephone numbers 8523-8461 up to 70 Local 105, either personally or at its email address: [crl@insurance.gov.ph](mailto:crl@insurance.gov.ph) for consideration in the liquidation of **FILMER** pursuant to pertinent provisions of Republic Act No. 10607, otherwise known as The Amended Insurance Code of the Philippines.

Parties who were able to file their claims with the Liquidator but failed to substantiate them and those who have not yet filed their claims with the said company are hereby given the last chance to file their claims under oath with the CRLD of the IC, either personally or by mail not later than 19 NOVEMBER, 2022, together with all supporting documents and/or relevant proofs detailing the character, basis and amount of each and every claim for consideration in the company's liquidation in accordance with pertinent provisions of the said Code.

**CLAIMS FILED AFTER 19 NOVEMBER, 2022 SHALL BE BARRED FOREVER AND SHALL NOT BE ALLOWED TO PARTICIPATE IN ANY MANNER WHATSOEVER IN ANY KIND OF DISPOSITION, PARTITION, DISTRIBUTION OR SETTLEMENT/PAYMENT IN THE LIQUIDATION PROCEEDINGS AGAINST FILMER. HENCE, ALL CLAIMANTS ARE ENJOINED TO TIMELY FILE THEIR RESPECTIVE CLAIMS.**

After 19 NOVEMBER, 2022, the deadline herein set for the filing of claims, the IC shall decide on the final termination and closure of liquidation proceedings of **FILMER** which shall be posted in the IC website at [www.insurance.gov.ph](http://www.insurance.gov.ph).
