 - f. The **prospective service partner** must have one (1) Cloud Platform Certified Architect/Engineer in its personnel roster.
 - g. The **prospective service provider** must provide an end-user training from CSP accredited trainers/instructors.
 - h. Must provide Certification Trainings and knowledge transfer (online or on-site) for five (5) IC administrators and five (5) end-users on a following topics:
 - i. Architecting for the chosen CSN
 - ii. Advance Architecting for the chosen CSN
 - iii. System Operations for the chosen CSN
 - iv. Security Engineering for the chosen CSN
