## TERMS OF REFERENCE

### Supply and Delivery of Air Purifiers for the Insurance Commission (IC)

(P.R. No. 2023-08-239A)

#### I. SCOPE

1. The prospective supplier shall bid for the **Supply and Delivery of Air Purifiers for IC**

***Minimum Specifications:***

- Air filtration process: At least 5 stages of Air Filtration
- Filters: With replaceable (commercially available) pre-filter and HEPA (high efficiency particulate air/absorbing/arresting) filter (at least H13)
- Other effective air purification features: Ion technology that deactivates air impurities
- Effective Coverage based on RFQ.
- Operational Functions/modes: Variable speed; sleep; timer

#### II. TERMS OF PAYMENT

1. The price quotation, to be denominated in Philippine Peso, should not exceed the Approved Budget for the Contract (ABC) of **Nine Hundred Fifty Thousand Pesos (PhP950,000.00)** inclusive of all applicable taxes and other charges.
2. The quoted prices shall be considered fixed and not subject to price escalation during contract implementation.
3. Price validity must be at least thirty (30) days from submission of quotation.
4. Payment shall be made within thirty (30) days after the complete delivery of required goods and services, and acceptance thereof by the IC. The IC shall not be held liable for any delay in the payment under reasonable and acceptable circumstances.
5. Bids received in excess of the ABC shall be automatically disqualified during bid evaluation.

#### III. GENERAL CONDITIONS

1. All entries in the Reply Slip/Quotation **must be typewritten in the company's letterhead, duly signed by the supplier/dealer or its duly authorized representative.**



2. **A Certified True Copy of the suppliers/dealer's valid PhilGEPS Registration Number/Certificate, including an original copy of the duly notarized Omnibus Sworn Statement (template attached), shall be attached to the quotation upon submission.**
3. The duly accomplished and signed **Reply Slip**, including the required documents enumerated therein, **must be submitted in person not later than 12:00 NN, 31 August 2023** to the Administrative Division – Supply Section through the following:

4. For verification/validation purposes, the original eligibility requirements of the company with the lowest calculated quotation are required to be presented, as necessary:
  - a. Valid PhilGEPS Registration Number/Certificate;
  - b. Business Registration issued by the Security and Exchange Commission (SEC), Department of Trade and Industry (DTI) or Cooperative Development Authority (CDA), whichever applicable;
  - c. Valid Mayor's/Business Permit issued by the city or municipality where the principal place of business of the prospective supplier is located;
  - d. Certificate of Tax Registration issued by the Bureau of Internal Revenue (BIR); and
  - e. Latest Income/Business Tax Return (ITR).
5. **The IC reserves the right to reject any or all Quotations/Bids, to annul the procurement process, to reject all Quotations/Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder(s), and to accept only the offer that is most advantageous to the Government.**

#### **IV. SPECIAL CONDITIONS**

##### ***Qualification of Supplier***

1. The supplier/bidder must be a holder of a valid business license/s issued by relevant government agencies and must be duly registered with the PhilGEPS.

##### ***Delivery of Services***

2. The schedule of delivery should be completed **Fifteen (15) working days upon receipt of Notice to Proceed (NTP).**

### ***Warranty***

3. Warranty against manufacturing defects, as well as parts and service;
  - Warranty Period: One (1) year for manufacturing defects and service.
  - Supplier of air purifiers must have accredited/authorized service centres in Metro Manila
  - Warranty shall commence upon issuance of the Certificate of Acceptance

### ***Maintenance***

4. Must conduct quarterly air quality monitoring, scheduled check-ups, air purifier positioning, and other related maintenance process.

### ***Limitation of Liability***

5. Subject to the Insurance Commission's obligation to pay the price due to the Supplier, either party's liability in contract, tort or otherwise (including negligence) arising directly out of or in connection with, this TOR or the performance or observance of its obligations under this TOR and every applicable part of it shall be limited in aggregate to the Price.

### ***Termination***

6. The agreement between the Insurance Commission and the Supplier shall be effective upon its approval by the former and acceptance by the latter, and shall continue, unless terminated sooner or until the completion date.
7. Either Party may terminate the agreement upon written notice if the other is in breach of any material obligation contained in this TOR, which is not remedied (if it is capable of being remedied) within fifteen (15) days of written notice from the other Party so to do.
8. Any termination of the agreement (howsoever occasioned) shall not affect any accrued rights or liabilities of either Party, nor shall it affect the coming into force or the continuance in force of any provision hereof which is expressly or by implication intended to come into or continue in force on or after such termination.

### ***Miscellaneous***

9. The failure of either party to enforce its rights based on the agreement under this TOR at any time for any period shall not be construed as a waiver of such rights.
10. If any part, term, or provision of this TOR is held illegal or unenforceable neither the validity nor enforceability of the remainder of the provisions shall be affected.

11. Neither Party shall be liable for failure to perform or delay in performing any obligation under this TOR if the failure or delay is caused by any circumstances beyond its reasonable control, including but not limited to acts of God, war, civil commotion or industrial dispute. If such delay or failure continues for at least five (5) days, the Party not affected by such delay or failure shall be entitled to terminate this Agreement by written notice to the other.
12. It is understood that all the relevant provisions of the Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, and its 2016 Revised Implementing Rules and Regulations shall apply, govern, and complement the agreement arrived at under this TOR.
