SUBJECT: Work Arrangements on Wednesday, 27 March 2024

Pursuant to Office of the President Memorandum Circular No. 45, s. 2024 (copy attached), work in the Insurance Commission (IC) is hereby suspended from 12:00 NN onwards on Wednesday, 27 March 2024. Moreover, IC officials and employees are authorized to work-from-home (WFH) on same day from 8:00 AM to 12:00 NN.

Divisions/Sections rendering frontline services, including the Conservatorship, Receivership and Liquidation Division, Licensing Division, Public Assistance and Mediation Division, Suretyship Section, Administrative Division – Cashier and Records Sections, and IC District Offices, have assigned skeleton workforce to assist the public from 8:00 AM to 12:00 NN.

MEMORANDUM CIRCULAR NO. 45
