## TERMS OF REFERENCE

### 1. Project Title

Supply, Delivery, and Installation of Uninterruptible Power Supply (UPS) Batteries (Project Reference No. 2024-10-283)

### 2. Objective

The primary objective of this project is to ensure the reliable and uninterrupted power supply to the Insurance Commission's data center by procuring, delivering, and installing new UPS batteries. The focus is on enhancing the resilience of the data center's power infrastructure, minimizing downtime, and safeguarding critical data and operational continuity. Through the meticulous execution of this initiative, this project aims to optimize the efficiency and performance of the data center, reinforcing its capacity to meet the demanding power requirements of modern insurance operations.

### 3. Specifications

The following UPS equipment shall be covered Supply, Delivery, and Installation of UPS Batteries for the Insurance Commission at 1071 United Nations Avenue, Ermita, Manila, Philippines:

### 4. Scope of Work

#### UPS Batteries Replacement Scope of Work

- Visual and Actual Inspection
  - Site condition and the UPS
  - Internal and External Batteries
  - Check if there's damaged parts before the activity
- Check UPS Measurements, Statuses, and Alarms
  - Check UPS electrical parameters and other UPS measurements to ensure that it is within normal range and tolerance. (e.g. Input and Output Supply, Load, Runtime, etc.)
- Checking of Battery Modules
  - Inspect if all are properly connected and are detected by the UPS or identify the unit to be replaced.
  - Identify the battery module that needs to be removed or replaced.
- Disconnection and Dismantling of Battery Modules

- Carefully disconnect and remove the module to be replaced
  - Proper angle tilting and removal of the battery module
  - Double check backplane of the frame for any sign of damage and interlocking connection issues
- Inspection of new battery module units
  - Check for any signs of damage as well as the interlocking connection before inserting the new battery module
  - Check for voltage supply of the battery module
  - Note: when replacing batteries, always replace with the same type and number of batteries or battery packs*
- Proper Handling, Positioning and Mounting of New Battery Module
  - Carefully guide the new battery module completely into the system
  - Insert the new Battery Module Unit
  - Ensure that all battery modules are properly inserted to the frame
  - Double check if the interlocking connection of the cartridges are connected to the backplane of the frame
- Monitoring Status of the New Module
  - Monitor the module status inserted
- Check and obtain UPS system measurements, parts and logic statuses and alarms after the power module replacement
- Monitoring of UPS and final inspection. Furnishing of report after the activity and signatory and turnover to the representative of the Insurance Commission

### **Service Availability Requirements**

- Service phone support availability 24 hours a day, 7 days a week including holidays. A two (2) hours response through phone call or email shall be provided from the time of the first call or email by Insurance Commission Personnel in case of trouble pertaining to the installed or provided items
- Must provide unlimited technical phone consultation within the warranty period
- On-site support must have a service response time not more than four (4) hours from the time of the call, in cases wherein the phone or email support could not solve the problem
- Service reports shall be submitted after the activity

### **Bidder's Qualifications**

- Bidder must be a platinum partner or with equivalent highest level of partnership and certification from the Manufacturer to ensure of its technical expertise on the offered solution.
  - Copy of the Certificate from the Manufacturer must be provided.
- Bidder should provide a certificate that it has 24x7 technical support capabilities together with its Technical Organizational Structure.
- Bidder must have one (1) employed Safety Officer for at least two (2) years
  - Certificate of Employment of the assigned safety officer
  - Copy of Certificate must be provided

- Bidder must have one (1) employed Certified Electrical Engineer for at least Two (2) years
  - Certificate of Employment of the employed Certified Electrical Engineer.
  - Valid PRC License of the Certified Electrical Engineer.
- Bidder must have at least one (1) Certified Data Center Professional (CDCP) employed for at least One (1) Year
  - Certificate of Employment of the Certified Data Centre Professional.
  - Certificate of Completion for the Data Center Certification Training Course issued to the bidder's CDCP.
- Bidder should have at least one employee that has experience and at least five (5) days training for the Symmetra PX 2 Uninterruptible Power Supply.
  - Certificate that he/she is certified to perform services on the said product line of APC by Schneider Electric. *(This is to instill expertise and establish that the personnel shall be capable in the installation services and can troubleshoot and repair any fault/alarm of the equipment it may encounter during the installation of the batteries.)*
- Bidders must conduct a site survey to fully grasp the requirements, area, and location of the equipment. Certification proof of conducting ocular from end-user.

## 5. Delivery Period

Supply, Delivery, and Installation of Uninterruptible Power Supply (UPS) Batteries must not be later than **Ninety (90) Calendar Days** upon receipt of the Notice to Proceed (NTP).

## 6. Service Level Agreement

The IC shall maintain a Service Level Agreement (SLA) with the contractor, with provisions for liquidated damages for their non-compliance which shall be charged against any money due, or which may become due to the contractor, or collected from any securities or warranties posted by the contractor.

- Renewal of License including features and specifications
  - 1/10th of 1% of the contract price for the undelivered portion shall be imposed per day of delay.
- Scope of Work
  - 1/10th of 1% of the contract price for the undelivered portion shall be imposed per day of delay.

## 7. Warranties

- The winning bidder warrants that it shall conform strictly to the terms and conditions of this Terms of Reference.
- The winning bidder shall neither assign, transfer, pledge, nor subcontract any part or interest to the contract being bided out.

## 8. Confidentiality of Data

- The IC Network and System, its components, parts, and all products, product samples, specifications, data, ideas, technology, and technical/non-technical materials, all or any which may be derived from any of the foregoing are strictly confidential.
- The winning bidder agrees to hold all the foregoing information in strict confidence. The winning bidder further agrees not to reproduce or disclose any confidential information to third parties without the prior written approval of the IC.

## 9. Payment Terms

- All bid prices shall be considered fixed and not subject to price escalation during contract implementation.
- One-time payment shall be made, subject to the submission of the following documentary requirements, and in with accordance to the budgeting, accounting, and auditing laws, rules, and standards:
  - Delivery Receipt
  - Sales Invoice/Billing Statement
  - Warranty and Acceptance Certificate
