- 6.1.3. All MFPs must be capable of connecting with the centralized Print Management Software to be installed in a dedicated workstation assigned by the IC as a Print Server. The supplied Print Management Software must be of the same brand as the MFPs to be deployed to ensure compatibility.
- 6.1.8. If refurbished, the entity must be an Authorized Service Provider of the brand for at least five (5) consecutive years.

TO:

- 6.1.3. All MFPs must be capable of connecting with the centralized Print Management Software to be installed in a dedicated workstation assigned by the IC as a Print Server. The supplied Print Management Software must be print management software that is compatible with the brand to be deployed to ensure compatibility.
- 6.1.8. If refurbished, the entity must be an Authorized Service Provider of the brand for at least five (5) consecutive years. Alternatively, provide Certified Onsite Technicians with acknowledged expertise in the brand offered.

This Supplemental Bid Bulletin No. 1 shall form part of the Bid Documents. Any provisions in the Bid Documents inconsistent herewith are hereby amended, modified, and superseded accordingly.
