TERMS OF REFERENCE

Repair and Maintenance of IC Facilities

I. SCOPE

 The Supplier/Bidder shall bid for the entire lot which shall include all items enumerated below and should not exceed the Approved Budget for the Contract (ABC) of One Million One Hundred Fifty-Five Thousand Two Hundred Two Pesos and 37/100 (Php1,155,202.37).

The Contractor shall warrant all installed materials/items for the period of one

 (1) year from project acceptance by the Procuring Entity/End user. The
 Contractor shall likewise be responsible for the repair of any defects that occur
 during the warranty period.

II. TERMS OF QUOTATION

- The price quotation, to be denominated in Philippine peso, should not exceed the ABC of One Million One Hundred Fifity-Five Thousand Two Hundred Two Pesos and 37/100 (Php1,155,202.37) inclusive of all applicable taxes and other charges.
- 2. The quoted prices shall be considered fixed and not subject to price escalation during contract implementation.
- 3. Price validity must be for a period of sixty (60) days from submission of quotation.

4. Payment shall be made within thirty (30) days after the complete delivery of required goods and services, and acceptance thereof by the IC. The IC shall not be held liable for any delay in the payment under reasonable and acceptance circumstances.

III. GENERAL CONDITIONS

- All entries in the Reply Slip/Quotation must be typewritten in company's letterhead, duly signed by the supplier/bidder or its duly authorized representative.
- Copy of the supplier's/bidder's valid PhilGEPS Registration Number/Certificate, including an original copy of the duly notarized Omnibus Sworn Statement (template attached), shall be attached to the Reply Slip/Quotation upon submission.
- 3. The duly accomplished and signed Reply Slip, including the required documents enumerated therein, must be submitted in person not later than 12:00 NN, 04 March 2025 to the Administrative Division General Services Section through the following:

- 4. For verification/validation purposes, the bidder with the lowest calculated quotation shall be subject to post-qualification and are required to present the original copies of the documentary requirements enumerated in the Reply Slip, as necessary:
 - a. Valid PhilGEPS Registration Number/Certificate;
 - Business Registration issued by the Security and Exchange Commission (SEC), Department of Trade of Industry (DTI) or Cooperative Development Authority (CDA), whichever applicable;
 - c. Valid Mayor's/Business Permit issued by the city or municipality where the principal place of business of the prospective supplier is located;
 - d. Certificate of Tax Registration issued by the Bureau of Internal Revenue (BIR);
 - e. Latest Income/Business Tax Returns (ITR);
 - f. PCAB License of at least category Trade/E; and
 - g. Proof of similar services to other government agencies within two (2) years immediately preceding the submission of quotation.
- 5. The IC reserves the right to reject any or all Quotations/Bids, to annul the procurement process, to reject all Quotations/Bids at any time prior to the contract award, without thereby incurring any liability to the affected

Bidder(s), and to accept only the offer that is most advantageous to the Government.

IV. SPECIAL CONDITIONS

Qualifications of the Supplier

- 1. The supplier/bidder must be a holder of valid business license/s issued by relevant government agencies and must be duly registered with the PhilGEPS.
- The supplier/bidder must have at least a Registered Civil Engineer or Architect. A copy of the valid license card must be submitted to the Administrative Division prior to implementation of the project.
- All prospective suppliers/bidders, prior to submitting their respective quotations, are required to inspect and examine the site and surroundings of the Proposed Project, to arrive at the most reasonable costing for the needed labor, materials, equipment and services.

The site inspection and examination shall be allowed on 28 February 2025 and 03 March 2025 at 9:00 AM until 3:00 PM. Any cost incurred during the site inspection shall be for the account of the prospective supplier/bidder. For this purpose, each prospective supplier/bidder shall submit a Site Inspection Certificate (template attached) issued by the Procuring Entity, which shall constitute part of the documentary requirement.

Delivery of Services

4. The supplier shall complete the delivery of all goods and services involved at the IC Main Office Building, 1071 United Nations Avenue, Ermita, Manila, including testing and commissioning, within Sixty (60) calendar days upon receipt of the Notice to Proceed (NTP).

Limitation of Liability

5. Subject to the Insurance Commission's obligation to pay the price due to the supplier, either party's liability in contract, tort or otherwise (including negligence) arising directly out of, or in connection with, this TOR or the performance or observance of its obligations under this TOR and every applicable part of it shall be limited in aggregate to the price.

Termination

- 6. The agreement between the IC and the Supplier shall be effective upon its approval by the former and acceptance by the latter, and shall continue, unless terminated sooner or until the completion date.
- 7. Either party may terminate the agreement upon written notice if the other is in breach of any material obligation contained in this TOR, which is not remedied (if it is capable of being remedied) within fifteen (15) days of written notice from the other party to do so.

8. Any termination of the agreement (howsoever occasioned) shall not affect any accrued rights or liabilities of either Party, nor shall it affect the coming into force or the continuance in force of any provision hereof which is expressly or by implication intended to come into or to continue in force on or after such termination.

Miscellaneous

- 9. The failure of either party to enforce its right based on the agreement under this TOR at any time of any period shall not be construed as a waiver of such rights.
- 10. If any part, term or provision of this TOR is held illegal or unenforceable neither the validity nor enforceability of the remainder of the provisions shall be affected.
- 11. Neither Party shall be liable for failure to perform or delay in performing any obligation under this TOR if the failure or delay is caused by any circumstances beyond its reasonable control, including but not limited to acts of God, war, civil commotion or industrial dispute. If such delay or failure continues for at least five (5) days, the Party not affected by such delay or failure shall be entitled to terminate this Agreement by written notice to the other.
- 12. It is understood that all the relevant provisions of the Republic Act No. 12009, otherwise known as the Government Procurement Reform Act, and its The Implementing Rules and Regulation (RIRR) shall apply, govern, and complement the agreement arrived at under this TOR.
