TERMS OF REFERENCE

Supply and Delivery of Vitamin Supplements for the Insurance Commission for CY 2025

(Purchase Request No. 2025-04-193)

1. Approved Budget for the Contract

The price quotation should not exceed the Approved Budget for Contract (ABC) inclusive of 12% VAT and all other applicable taxes and charges, as follows:

2. Mode of Procurement

The mode shall be Negotiated Procurement – Small Value Procurement as provided under Section 34 of the Implementing Rules and Regulations of Republic Act (R.A.) No. 12009, otherwise known as the New Government Procurement Act.

5. Other Documents Required for Awarding of Contract

The bidder with the Lowest Calculated Quotation (LCQ) shall be required to submit and present the following documents, for verification/validation:

- 5.1. Copy of this project's TOR, duly signed by the supplier/dealer or its duly authorized representative;
- 5.2. Proof of PhilGEPS Registration/PhilGEPS Registration Number;
- 5.3. Valid Mayor's/Business Permit;
- 5.4. Business Registration (SEC/DTI/CDA);
- 5.5. Certificate of Tax Registration issued by the Bureau of Internal Revenue;
- 5.6. Latest Income/Business Tax Return;
- 5.7. Notarized Omnibus Sworn Statement per attached template;
- 5.8. Certificate of Product Registration (CPR) issued by the Food and Drug Administration (FDA), and Product Specifications issued by the Manufacturer; and
- 5.9. License to Operate (LTO) issued by the FDA for Suppliers, Distributors and Traders.

At the option of the IC, the supplier with the LCQ shall present the original copies of the documents for verification/validation.

6. Terms of Payment

The payment for the service rendered shall be made within thirty (30) days after the complete delivery and acceptance of the items and issuance of billing statement by the supplier.

The IC shall not be held liable for any delay in the payment under reasonable and acceptable circumstances.

7. Limitation of Liability

Subject to the IC's obligation to pay the price due to the Supplier, either party's liability in contract, tort or otherwise (including negligence) arising directly out of or in connection with this TOR or the performance or observance of its obligations under this TOR and every applicable part of it shall be limited in aggregate to the Price.

8. Termination of Contract

- 8.1. The agreement between the Insurance Commission and the Supplier shall be effective upon its approval by the former and acceptance by the latter, and shall continue, unless terminated sooner or until the completion date and completion of issues to be delivered.
- 8.2. Either Party may terminate the agreement upon notice in writing if the other is in breach of any material obligation contained in this TOR, which is not remedied (if it is capable of being remedied) within five (5) days of written notice from the other Party so to do.
- 8.3. Any termination of the agreement (howsoever occasioned) shall not affect any accrued rights or liabilities of either Party, nor shall it affect the coming into force or the continuance in force of any provision hereof which is expressly or by implication intended to come into or continue in force on or after such termination.

9. Liquidated Damages

Liquidated damages under Section 71.1.4 of the IRR of R.A. No. 12009 shall apply.

10. Warranty Terms

- 10.1. The Supplier shall provide replacement of all vitamin supplements delivered to IC bearing an expiration date of less than one (1) year from the actual delivery.
- 10.2. The Supplier shall provide replacement of all vitamin supplements found to have damaged or broken packaging prior to the acceptance of the procuring agency.

11. Miscellaneous

- 11.1. The failure of either party to enforce its rights based on the agreement under this TOR at any time for any period shall not be construed as a waiver of such rights.
- 11.2. If any part, term or provision of this TOR is held illegal or unenforceable neither the validity nor enforceability of the remainder of the provisions shall be affected.
- 11.3. Neither Party shall be liable for failure to perform or delay in performing any obligation under this TOR if the failure or delay is caused by any circumstances beyond its reasonable control, including but not limited to acts of God, war, civil commotion or industrial dispute. If such delay or failure continues for at least 7 days, the Party not affected by such delay or failure shall be entitled to terminate this Agreement by notice in writing to the other.
- 11.4. It is understood that all the relevant provisions of the R.A. No. 9184 and its Revised Implementing Rules and Regulations shall apply, govern, and complement the agreement arrived at under this TOR.

12. General Conditions of the Contract

- 12.1. All entries in the quotation must be typewritten in the company's letterhead, duly signed by the supplier/dealer or its duly authorized representative.
- 12.2. PHILGEPS Registration Certificate shall be attached to the quotation upon submission to the contact person provided in the RFQ.
- 12.3. Price validity shall be for a period of thirty (30) days from submission of quotation.
- 12.4. All quotations shall include all applicable taxes, delivery charge and shall be considered as fixed prices. Same shall not be subjected to price escalation during contract implementation.
- 12.5. For verification purposes, the bidder with the lowest bid shall be required to present the original copy of the required documents upon submission, specified in Item V of the TOR, as appropriate.
- 12.6. The IC reserves the right to reject any or all Quotations/bids, to annul the procurement process, to reject all Quotations/Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder(s), and to accept only the offer that is most advantageous to the Government.
