## **NOTICE TO THE PUBLIC**

Notice is hereby given that the Insurance Commission has placed **CARITAS FINANCIAL PLANS, INC.** under **LIQUIDATION** pursuant to Section 50 of Republic Act No. 9829, otherwise known as the *Pre-Need Code of the Philippines* **effective 05 May 2025**.

**All planholders of the CFPI are hereby enjoined to verify their names through the online verification portal at <https://www.cfpi.com.ph/phcp>.**

Planholders having claims against the company or claimants whose names are not found in the above portal are hereby notified to file their claims with the IC-appointed Liquidator, **ATTY. JOSE A. BARCELON** not later than **One Hundred Twenty (120) days** from the last publication of this Notice on **19 May 2025** or until **16 September 2025**, together with all supporting documents and/or relevant proofs, detailing the character, basis and amount of each and every claim for consideration in the company's liquidation, pursuant to pertinent provisions of Section 50 of Republic Act No. 9829, otherwise known as the "*Pre-Need Code of the Philippines*."

CLAIMS FILED AFTER **16 September 2025** SHALL BE BARRED FROM THE NORMAL LIQUIDATION PROCEEDINGS BUT INSTEAD SHALL BE REFERRED TO THE COMPANY FOR RECONSIDERATION IN ITS DISSOLUTION AND WINDING UP PROCEEDINGS. HENCE, ALL CLAIMANTS ARE REMINDED TO FILE THEIR CLAIMS ON TIME.
